1. The purpose of this modification is to clarify the required tax calculation methodology in Section J.

2. The contract is modified as follows:

Section J

- A. The Table of Contents for Section J is updated to reflect repagination due to the changes described below.
- B. The numbered list in Section J.2.5.1.7 is modified to insert a new item 1 at the top of the list reading:

"1. The contractor shall separately calculate each tax, fee, or surcharge applicable to each BI line item.

- Only those taxes included in the Allowable Taxes (ALLTAX) reference table may be charged.
- The contractor shall apply the tax, fee, or surcharge rate and calculation parameters in effect on the date of service delivery for all taxes, fees, and surcharges except the Federal Universal Service Fund (FUSF). For the FUSF, the contractor shall apply the tax, fee, or surcharge rate and calculation parameters in effect on the date of billing."
- 3. The estimated dollar value of the contract remains unchanged.

4. Except as provided herein, all prices, terms and conditions of the document referenced in Item 10A remain unchanged and in full force and effect.
